

# Public Sector Collective Bargaining in Missouri

Presented by the *MU Labor Education Program, University of Missouri – Columbia Extension*

This class will provide an overview of public sector labor relations policy in the state of Missouri. Primary attention will be focused on discussion of national trends in the regulation of labor-management relations in public service, with a comparative look at how these issues are addressed in Missouri. Among the issues covered are the scope and coverage of organizing and bargaining rights, methods



for the establishment of representational rights and the determination of bargaining units, strategies for the enforcement of the duty to bargain and collective agreements, the scope of bargaining in the public sector, options for the resolution of impasses in bargaining, and related issues.
